

- Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to B.S. EDUCATION KULTAJPUR 2922/2, NARNAUL, MOHINDERGARH, HARYANA for conducting B.ED. course of 1 year duration with an annual intake of 100 students under clause 7 (12) of NCTE Regulation dated 13th Jan 06 subject to fulfillment of the follwoing:
 - (i). The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account to be operated along with an official of the Regional Committee.
 - (ii) The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, as amended from time to time.
 - Further, the recognition is subject to fulfillment of all such other requirements as Further, the recognition is subject to the regulatory bodies like UGC and State Government, etc, may be prescribed by other regulatory bodies like UGC and State Government, etc, wherever applicable.
